TERMS AND CONDITIONS

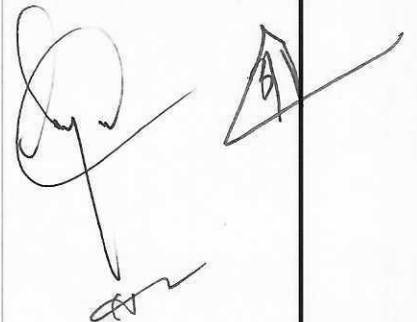
1. SCOPE OF WORK:-

- 1.1. The college shall provide space 10 X 12 Sq. feet near Administrative Block, Dr. RKGMC Hamirpur for construction of pre-fabricated removable booth which will be set up by the successful bidder with minimum damage to land underneath at his own cost within 15 days of award letter.
- 1.2. The successful bidder will provide branded Beverages & Eatable items as per Annexure-I in Vending Corner in the premises of Dr. RKGMC Hamirpur (HP) on monthly rent basis.
- 1.3. The minimum rent of pre-fabricated booth of Vending Corner will be assessed by HP PWD.
- 1.4. The Successful bidder will sell Beverages & Eatable items of best Branded Products.
- 1.5. The Vending Corner shall remain opened 24x7 hours.
- 1.6. The successful bidder will install fire-extinguisher of appropriate capacity in proportion to spaciousness of booth.

2. RESPONSIBILITY & INSTURCTIONS TO THE BIDDER.

- 2.1 The bidder must submit bids in two sealed envelopes separately i.e. the Tender form duly signed on every page along with all the required documents in one envelope (**Envelope-A**) super-scribed as Technical Bid and second envelope (**Envelope-B**) super-scribed as Financial bid and both the envelopes **A & B** shall be put in single envelope super-scribed as Tender for Vending Corner.
- 2.2 The Booth Vendor will bear all the expenses for running the shop and Dr.RKGMC Hamirpur shall not in any manner be responsible for any damage caused due to incidents like theft, burn, fire, electric shock or bear any compensation for damage or injury caused to its workmen during discharging their duty.
- 2.3 The Booth Vendor will not be allowed to use the booth allotted by Dr.RKGMC Hamirpur for any other purpose or business and if found to be used for other purpose, the contract shall be terminated immediately.
- 2.4 The persons associated with selling specified items will be required to undergo periodical medical check-up to rule out the possibilities of communicable disease /infectious diseases and if anybody found suffering from such diseases has to be kept out of engagement till he/she is fully recovered. Annual medical certificate of fitness is to be deposited in the office of Principal, Dr. RKGMC Hamirpur (HP).
- 2.5 All the documents should be self-attested by the bidders and proper paging should be marked.
- 2.6 The booth vendor is expected to maintain a courteous demeanor towards students, staff, authorities and general public. The vendor must refrain from engaging in or permitting gambling, drinking or any unlawful and antisocial activities in or found participating in such activities, their contract will be terminated immediately.



- 2.7 The College & Hospital Campus is a “**NO SMOKING ZONE**” hence sale and use of tobacco is prohibited “**No Smoking Zone** “sign must be displayed prominently.
- 2.8 The Substandard eatable items will be prohibited. If any substandard eatable items are found, it will be destroyed immediately by Committee framed by Principal and no compensation/claim will be given.
- 2.9 The authorized Govt. Agencies will have the liberty of taking samples for Chemical analysis to ensure quality as per provisions of the Acts/Rules. The quality assurance of product items shall be done by periodically sampling by the Institution. The vendor will be held fully responsible for any violations of the provisions of the Act and its associated rules.
- 2.10 There will be cleanliness in and around the booth. The Booth vendor, his workers and representatives shall comply with all instructions given by the Principal, Dr. RKGMC Hamirpur (HP) or his representative whether in writing or verbally.
- 2.11 The Booth vendor, his servants and representatives shall wear proper uniform. No employee under the legal age, as defined by Labor Laws shall be permitted to work at the booth.
- 2.12 The booth vendor shall ensure to dispose off Bio Medical Waste as well as ordinary Waste, if any at his own cost/level in an eco-friendly manner.
- 2.13 The Booth vendor will be responsible to pay minimum wages as notified by the state Govt. to his/her employees engaged in the booth through RTGS/NEFT. Also he/she will maintain accurate record of the emoluments provided to his/her employees.
- 2.14 In case of breach of the contract, Principal, Dr. RKGMC Hamirpur (HP) may forfeit the performance security money without assigning any notice to the tenderer.
- 2.15 The Dr.RKGMC Hamirpur reserves the right to cancel the Tender at any stage of Tender process without assigning any reason thereof.
- 2.16 The Booth vendor /bidder will pay the rent assessed by HP PWD on monthly basis to this office in advance before 5th of every month. The vendor will pay six month rent in advance as a security fee.
- 2.17 The vendor will be liable to pay all other rent, rate & taxes payable under GST/service Act/ VAT/ income tax or any tax imposed by the government from time to time.
- 2.18 The successful bidder Booth Vender will have to sign an agreement with Estate Officer, Dr.RKGMC Hamirpur as per HP Shops and Commercial Establishment Act on non-judicial paper of Rs. 100/- for fulfilling the terms & conditions of shop.



- 2.19 The successful bidder Vendor shall have to install electricity and water meter in the allotted pre-fabricated Vending Corner at his own cost & his/her name and he will pay all periodical bills himself.
- 2.20 The booth vendor shall be responsible for adhering to all statutory requirements.

3. ELIGIBILITY CRITERIA

Following documents are required for Technical qualification of Bids.


- i) The bidder should be bonafide Himachali.
- ii) He should attach Permanent Residential document proof (Local /Permanent) either of Voter card/ Aadhaar card/Ration card
- iii) The booth holder should submit undertaking that he is not blacklisted from any Govt. Institution on Rs.100 Stamp paper.
- iv) The Booth holder should submit declaration that there is no ongoing police case/ vigilance inquiry against him/ his Partner and he/she has never been convicted or punished by any Court of Law Rs.100 Stamp paper.
- v) The Bidder must have a minimum of two years of experience providing booth services in any government or private educational institution, with documentation attested by the head of the respective institution.
- vi) The total turnover of the bidder should be minimum Rs.20 lakh or more for the last two financial years continuously.

4. SELECTION CRITERIA

- i) The Bidders have to quote rates for sealed pack items and machine made eatables as per attached proforma.
- ii) For Packed/sealed items, the bidders will quote for maximum retail price and price after discount.
- iii) The lowest Bidder will be selected on the basis of total cost of all items quoted.
- iv) In case of tie, the L-1 bidder will be selected on the basis of Lottery/ Toss.

5. EARNEST MONEY DEPOSIT (EMD)

- 5.1 An EMD of Rs.25,000/- (Rs. Twenty five thousand only) in the form of FDR in the name of Principal, Dr. RKGMC Hamirpur HP) should be enclosed with the bid and should be valid till 180 days from the last date of submission of the bid.
- 5.2 The EMD of unsuccessful bidders will be returned to them without any interest, after the award of the tender to successful bidder. The EMD of the successful vendor will be returned without any interest, after receipt of performance security as per the terms of contract.

5.3 The EMD of a bidder may be forfeited without prejudice to other rights of the vendor, if the bidder withdraws or amends its tender or impairs or derogates from the Tender in any respect within the period of validity of its tender or if it comes to notice that the information/ documents furnished in its tender are incorrect, false, misleading or forged. In addition to the aforesaid grounds, the successful bidder, EMD will also be forfeited without prejudice to other rights of vendor, if he/she fails to furnish performance security within the specified period.

6. PERIOD OF CONTRACT AND RENEWAL OF CONTRACT:

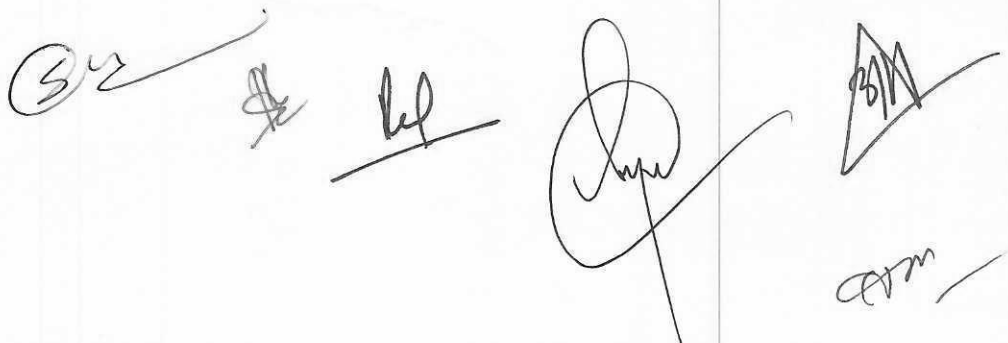
- 6.1 The contract, if awarded will be initially for three years from the date of award of contract which can be extended for another two years subject to continuous satisfactory performance. In no case extension will be granted further after total 05 years and a new tender will be floated.
- 6.2 The successful bidder will provide an affidavit that he will vacate the space within fifteen days after completion of awarded contract period or on receiving orders from Principal, Dr.RKGMC Hamirpur if in any case and due to any reasons the contract terminates before end of contract.
- 6.3 The rent assessed by the HP PWD authorities will be fixed in the form of FDR in the name of Principal, Dr. RKGMC, Hamirpur - HP for initial one year. Subsequently, the rent will be subject to an annual increase of 10%.

7. TERMINATION OF CONTRACT

- 7.1 On the recommendation of the Committee, the Principal, Dr. RKGMC Hamirpur (HP) reserves the right to terminate the contract in the event of repeated non-compliance with the terms & conditions of the tender.

8. Performance Security

- 8.1 The Successful bidder (booth vendor) shall deposit six month rent in advance as a performance security in the shape of fixed deposit issued by a Nationalized Bank in favour of Principal, Dr. RKGMC Hamirpur (HP). This shall be submitted within 15 days (minimum) of receiving of letter for Award of Contract, failing which the EMD may be forfeited and the contract may be cancelled.
- 8.2 If the booth vendor/ contractor violate any of the terms & conditions of contract, the Performance Security shall be liable for forfeiture, wholly or partly, as decided by the Authority and the contract may also be cancelled.
- 8.3 The Authority will release the Performance Security without any interest to the firm/contractor on successful completion of contractual obligations.



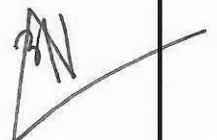
9. PENALTIES

- 9.1 The vendor selected for selling the Beverages & eatables items, will be required to maintain highest level of cleanliness and standard of hygiene in the booth. A penalty of Rs.500/- per occasion shall be imposed for each instance of non-compliance.
- 9.2 The Vending Corner holder should keep daily needs items neat & clean. If at any point the booth/ its premises are found to be unclean, the booth holder shall be held responsible and penalty of Rs.100/- per occasion shall be imposed.
- 9.3 The Vending Corner holder will not be allowed to use the booth allotted by the College for any other purpose or business, if found used for other purpose shall be liable for penalty of Rs. 500/- per occasion & even lead to termination of contract.
- 9.4 There shall be no compromise on the quality of daily needs items provided by the dealers and if any such incidence or product adulteration is found, Rs.100/- per occasion penalty including black listing the firm, and action shall be taken under provisions of Prevention of Food Adulteration Act and non-compliance of the provisions of the Act may lead even to termination of the contract.
- 9.5 The rent of the booth will have to be paid by the 5th of every month in advance, in case of holiday, on the next working day, failing which penalty @ Rs.500/- per day shall be imposed for delayed period.
- 9.6 The successful bidder will display, prominently the list showing rates of each items at cash counter on (4'x3') board. In the event of violation of this condition, penalty @ Rs.500/- at a time shall be imposed and the appliances will be confiscated.
- 9.7 The Successful Bidder will sell only those items which are mentioned in the tender. In any case any violation found then penalty @ 1000 each item will be levied. Further, if any item is to be added on the demand of MBBS Students/ Staff members the prior permission will be mandatory from the committee as approved by the Principal, Dr. RKGMC Hamirpur.

10. ARBITRATION

- 10.1 Any difference(s) or disputes(s) which may arise will be settled by the Principal, Dr. RKGMC Hamirpur (HP) and if the need arises, the case will be referred to the Director Medical Education & Research, HP Shimla for final adjudication.

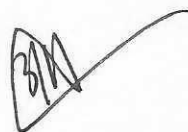

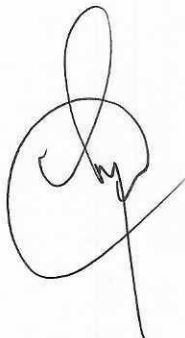
