1. Installation Requirements:

- 1.1 The installation of the Connectivity shall be carried at Dr. Radhakrishnan Govt. Medical College, Hamirpur District Hamirpur, Himachal Pradesh- 177001
- 1.2 Any statutory requirement for installation and working of all equipment of the ordered Fibre Connectivity/ Radio Frequency shall be responsibility of the bidder.
- 1.3 Permission from various authorities may be the sole responsibility of the bidder.

2. Specification of Equipment and Services:

Time for this purpose shall be measured as interval between the time of reporting the problem and the time when the problem is fully solved making the faulty components/functions fully operational.

4. Uptime Guarantee:

Vendor shall have to guarantee continuous uninterrupted internet line availability along with all the equipment supplied by them and should achieve minimum 98 % uptime across 24 X 7 calculated on monthly basis.

5. Spares:

Vendor shall maintain the sufficient Spares for maintaining required uptime.

INSTRUCTIONS TO TENDERERS

1. Definitions:

In this Contract, the following terms shall be interpreted as indicated below:

6. Qualification Criterion

- 6.2 Average Annual turnover of the bidder for the last 3 financial Years i.e. 2021 2022, 2022 2023 and 2023 2024 should be minimum Rs. 40Lacs for each financial year.
- 6.3 ISP License The bidder should have a valid Class A ISP License.
- 6.4 The ISP should provide the Last mile connection through Optical Fibre Cable/Radio Frequency.
- 6.5 The ISP should have a fully functional Customer Service Centre in North India.
- 6.6 The ISP should have centralized trouble ticketing tool for call logging, monitoring and Troubleshooting purpose
- 6.7 ISP should not be blacklisted in any PSU OR Govt. Organization in the last Five years
- 6.8 ISP should have 365 days online technical support.
- 6.9 ISP should have 365 days online call login facility through e-mail, toll free no.
- 6.10 ISP must have on call engineer for attending any urgent issue at customer premise.
- 6.11 ISP must have same service (Internet/Internet lease line) operation in 03 states.
- 6.12 ISP must have delivered minimum 05 order of same or above band width (subsequent proof to be submitted with technical bid)

7. Penalty Clause

The bidder should have to regulate interrupted internet services within 04 hours of written/telephonic complaint. In case of default, penalty @Rs 1000/- (Rupees One Thousand only) per hour will be imposed.

8. Offer Validity Period

Bid validity of Tender should remain valid for 30 days

9. Completeness of Tender Offer

The Tenderer is expected to examine all instructions, forms, terms, conditions and specifications in the Tender document. Failure to furnish all information required by the RKGMC. Tender document or submission of a tender offer not substantially responsive in every respect to the tender documents will
