c)	Reserve Price /Govt. Rate	The reserve price of the article has been decided & kept in record by the Committee and any offer below the reserve price will not be entertained.
d)	Opening of Bids	Bids will be opened as per the above mentioned schedule. The bidders, if interested may be present during bid opening process and only one representative from one firm will be allowed. In case any date mentioned above happens to be a holiday next day will be considered as due date.
e)	Award of Tender	The tender will be awarded to the H1 bidder (higher rate quoted for unserviceable store article by bidder) only
f)	Earnest Money	DD/FDR for an amount of Rs. 50,000/- in favour of "Principal, Dr. RKGMC Hamirpur to be attached with the tender otherwise tender is liable to be rejected. EMD will be returned to the unsuccessful bidders after the finalization of contract and in case of successful bidder, it will be adjusted against the contract value. The EMD amount does not carry any interest.
g)	Quality & quantity	The condemned items will have to be lifted by the successful bidder on "As is where is basis ". The department will not be responsible for giving the material by measurement etc. No claim whatsoever regarding quality, quantity, measurement shall be entertained.
